# What we do with your personal information?

We use your information to facilitate the following elements of your employment contract:

- Salary
- Pension
- NI contributions

## Who else do we give access to your information and why?

#### Clients

To facilitate our business operation, we need to pass personal information between us and our clients and suppliers, this information only includes:

- Name
- Business email address
- Business mobile phone number

#### **Business Partners**

We also need to share your information with some of our business partners, who process personal information on our behalf, to facilitate the salaries and pension elements of your employment contract, these partners include:

- Pension Company
- Etc.

#### What we don't do with your personal information

- We do not use your information for profiling or automated decision making
- We don't transfer your information outside of the European Union

#### How long do we keep your personal data?

We will retain your personal information for the duration of your employment with us and for some of the data, for a further 6 years because of our legal obligations. Bank account and next of kin information will be deleted once you have received your final salary payment and when that information is no longer required.

All other Personal information relating to performance, disciplinary information, skills and general communications about you and with you will be retained for three months after you are no longer an employee of the company so that we can provide a reference for you, if you require us to do so.

# What are your personal data rights?

If at any point you believe the personal information we hold on you is incorrect, you want us to correct or delete that information, or you no longer want us to hold that information or contact you, you can exercise your rights under the current Data Protection laws. These rights include:

- Right of access
- Right to rectification
- Right to erasure
- Right to restriction of processing
- Right to data portability
- Right to object

Please note, we will not be able to delete information that is required to maintain our business purpose or that is required to facilitate your contract of employment.
